To that end, we believe that it is necessary to develop multilateral cooperation in the sphere of social support for the young generation and to protect their rights and interests. In the current conditions of rapid development of

communication technologies, he proposed to develop a generalized international legal instrument - the International Convention on the Rights of Youth, But in the 21st century, in which we live, this question really becomes a question of life and death," he said. Therefore in our country «education of independent thinking youth, able to take responsibility for the future of our country, enterprising and full of enthusiasm» has been defined as one of the priority directions of development of social sphere. PF-5106 of July 5, 2017 «On increasing the effectiveness of the state youth policy and supporting the activities of the Youth Union of Uzbekistan PF-5106 of January 25, 2018 «General average», Resolution PF-5313 «On the measures for the radical improvement of the system of secondary special and vocational education», as well as the Resolution PF-5313 of 14 March 2017 «On the measures to improve PQ-2829 of 14 March 2017 «On the measures for further improvement» PQ-2883 of 14 March 2018 Resolution of the Republic of Uzbekistan Presidential Decree of 9 January 2019 PF-5618 «On the fundamental improvement of the system of crime prevention and control» The system of raising legal awareness and legal culture in the society» serves as legal documents when crimes are committed by minors. It should be noted here that the Ministry of Internal Affairs and the Ministry of Higher and Secondary Special Education «On measures to further improve the system of crime prevention among minors and young people» discuss a draft resolution: introduction of the position of inspector for work with minors and young people in higher education institutions at the expense of extrabudgetary funds of the university and inspectors for work with minors and young people of higher education institutions at the same time with the corresponding university for professional activities, The Ministry of Internal Affairs has issued an opinion on the adoption of proposals to determine the responsibility of crime prevention units. This will serve to establish an effective mechanism in this regard.
