In the first phase (1991-1994), the focus was on improving maternal and child health services, stabilizing demographics, and reducing communicable diseases. As a result, hospitalization decreased from 18.3% in 1997 to 13.8% in 2001.

#### **Results and conclusion.**

A new era in the development of health care began in 1998 - on November 10, 1998 by the Decree of the President of the Republic of Uzbekistan in 1998-2005. The State Program on Reconstruction of the Storage System was adopted. It outlined measures to improve the quality of medical care for the population. Under this program, measures have been taken to strengthen the primary health care system and to develop general practice. A new form of emergency medical care has been introduced. As a result, the provision of emergency medical care in all regions of the country, the provision of qualified medical care by calling a doctor at home. The main directions of development of maternal and child health services (2000), Mother and Child (2001), and Additional Measures to Improve the Health of Women and the Generation (2002). Medical screening of women of childbearing age for the detection and treatment of extragenital diseases has been intensified, contraceptive services have been increased, the consequences of early and close marriages among the population, especially among young people, and pregnancy in women with extragenital diseases and awareness-raising on birth prevention has been intensified. In order to prevent the birth of children with congenital defects and inherited diseases, a system of screening of mothers and children has been established, and work is underway to establish the State Register of Genetics.
